# 13. Budget 2021 Enhanced Regional Allocation \*circulated via email Shannon Doubleday, FNIHB

- provided Subcommittee overview of Budget 2021 Enhanced Regional Allocation and Briefing note options could look at combining life promotion suicide prevention and the regional mental Wellness possible funding to come up with a larger pot of money just under \$5 million that we could then look at strategically investing in the Indian residential school strategy, could also look at combining life promotion suicide prevention and regional mental Wellness needs funding again that almost five million with a recommendation that would be provided to all 46 personations of funding using the 50% basis is 2% merger but we could look at those things there's risks benefits either of them the risk of option number two under the light promotion suicide prevention and mental Wellness need funding is that we've already flowed significant amount of funding top-ups out nation service fiscal years on the first six months we flowed in additional about \$18 million we are at risk of recipients not being able to carry funding forward as we continue to flow out later and later in the fiscal year which that means we're looking at potentially climb money back or bring money back because it can't be expanded so there's some risks around that
- brainstorm discussion Life promotion suicide prevention funding and the regional mental Wellness



- question: life promotions and suicide prevention are there any training provided for the staff who are involved maybe that's something that we could look at is to have you know just different training opportunities maybe it could be originally it could be by treaty area
- response can be applied for training we did talk yesterday about a portion of the budget 2021 mental wellness crisis response team funding for this fiscal year, a chunk to be carved off for training and capacity development and to prepare nations for appending RFP for the expansion of crisis response teams
- through the IRS there's training the group indicated that they would like preference for iron for the RHS WS and CSP's in that training and if there's space to be able to open that up with it broader so there's some training coming down the line this year that would align with this year
- cautious about it being late in the year and layering on a lot of trading between those different funding
  pots so there's opportunities though for communities too to ask for times to expend the funds
  additionally only challenge we have is there's a fairly large number of recipients that are coming to the
  end of their five-year agreement so we have to seek permission in essence for agreement to be
  extended by one year in time only to allow the carryover funding
- Caroline shared it's unfair to the Nation the communities that funding is coming so late and there's a risk of the monies being clawed back, think it's something that the region needs to advocate that funding won't be clawed back
- Patricia Louie clarified the extension in time only as for conversations with the health funding arrangement team is typically the only allow agreements to do it twice and that's the absolute maximum that has historically been able for them to extend those in time only before starting a new agreement and you can't carry forward funding from an old agreement to a new agreement; in the beginning of the pandemic saw a lot of agreements extended then in 2021 they were then extended a second time only, so we actually have other NGOs treatment centres and tribal organisations and communities we have 34 that are due to expire this fiscal year and while we are trying to work with HFA to bring it up to national to see if there is a possibility for an additional extension it's at this time is not guaranteed and we're not sure if in one we will get an answer regarding that
